THAILAND – JAPAN business partnership to develop the first Industrial Estate in Ubonratchathani province, Thailand

Recently, Ubonratchathani Industry Company Limited, Kaigai Company Limited, Wellness Life Project (Thailand) and Asian Dynamic Communication Company Limited signed a memorandum of understanding (MOU) on 18 February 2019 to develop the first industrial estate in Ubonratchathani province, North-Eastern region, Thailand.

The project will be developed for Ubonratchathani Industrial Estate as their first property aimed at creating new opportunities for agriculture, bio-economy and a circular economy. The project will help stimulate regional socio-economic development and empowerment while reducing inequality, labor migration, and centralization. Ubonratchathani Industrial Estate will be the first Smart and Sustainable industrial park in Ubonratchathani province. Currently the province has a population of more than 1.8 million, with more than 10 million people in neighboring provinces in South Isan. The partnership between the four organizations will serve as a model of how industry-led sustainable development derives from foreign direct investment, enhances the local economy, provides employment, and creates valuable socio-economic transformation in the region. A total of 2,300 rai of land in Ubonratchathani Industrial Estate will be converted to industrial properties, modern logistics facilities, commercial space, and an innovation hub for SMEs. Combined, these developments will generate an economic impact of more 20 billion baht and provide approximately 20,000 jobs by 2022. The construction of the industrial estate is expected to begin by 2020 and will be completed by 2022.

Ubonratchathani Industrial Estate will operate with the objective of creating marketled sustainable development. Its development will provide foreign investors with the opportunity to use Thailand as a manufacturing base, regional business center, and logistics & supply-chain hub to deliver goods from Southeast Asia to other regions. The location of the industrial estate makes it particularly suitable for border connectivity with neighboring countries in the Emerald Triangle sub-region – namely, Cambodia, Lao PDR, and Vietnam.



Mr. Nattawatana Lerdsuravitaya, Managing Director at Ubonratchathani Industry Company Limited, stated that the company plans to invest approximately 2,700 million baht to develop and establish the industrial estate on 2,300 rai of land located at Na Krasaeng and Thung Thoeng sub-districts, Det Udom district, Ubonratchathani province. The project focuses on the agro-processing and biotechnology industries, also including cross-border tourism and hospitality, healthcare and wellness, machinery and automation for agriculture, and other industries to support the region's potential as a bio-hub.
